1. Which comes closest to your position on abortion? Do you think abortion should be...

Legal in all cases	23%

2. As you may know, the Supreme Court agreed to review a Mississippi law that bans most abortions after 15 weeks, or about 3 1/2 months into a pregnancy. Would you support or oppose a ban on most abortions after 15 weeks in your state?

3. Regardless of whether you agree with it, how likely do you think it is that the U.S. Supreme Court will rule that most abortions can be banned after 15 weeks of pregnancy?

Interviewing Dates	June 3 - 6, 2022
Target population	U.S. Citizens, aged 18 and over.
Sampling method	Respondents were selected from YouGov's opt-in Internet panel using sample matching. A random sample (stratified by gender, age, race, education, geographic region, and voter registration) was selected from the 2018 American Community Study. Voter registration was imputed from the November 2018 Current Population Survey Registration and Voting Supplement.
Weighting	The sample was weighted based on gender, age, race, education, news interest, and 2020 Presidential vote (or non-vote). The weights range from 0.179 to 2.977, with a mean of one and a standard deviation of 0.342.
Number of respondents	1000
Margin of error	± 3.3% (adjusted for weighting)
Survey mode	Web-based interviews
