

Daily Survey: Abortion Laws in the U.S.



Sample 1000 U.S. Adult Citizens
Conducted March 31 - April 4, 2022
Margin of Error ±3.4%

1. When do you believe human life begins?

At ovulation, when an egg is released but not yet fertilized	3%
At conception, when the egg is fertilized	28%
At implantation, when a fertilized egg is implanted in the wall of the uterus	4%
Within the first 8 weeks of pregnancy, when an embryo develops into a fetus and during the time when a heartbeat can usually be detected	14%
Between 8 weeks and three months of pregnancy, which includes the first trimester	4%
Between three and six months of pregnancy, which is the second trimester	4%
Between six months and birth, the third trimester, when a fetus typically has the ability to survive a preterm birth	11%
At birth	18%
Other	1%
Not sure	12%

2. When do you think abortion should be legal?

Abortion should always be legal. There should be no restrictions on abortion.	26%
Abortion should be legal, but with some restrictions (such as for minors or third-trimester abortions).	27%

Interviewing Dates	March 31 - April 4, 2022
Target population	U.S. Citizens, aged 18 and over.
Sampling method	Respondents were selected from YouGov's opt-in Internet panel using sample matching. A random sample (stratified by gender, age, race, education, geographic region, and voter registration) was selected from the 2018 American Community Study. Voter registration was imputed from the November 2018 Current Population Survey Registration and Voting Supplement.
Weighting	The sample was weighted based on gender, age, race, education, news interest, and 2020 Presidential vote (or non-vote). The weights range from 0.281 to 6.5, with a mean of one and a standard deviation of 0.45.
